The International Code Council requires that all Governmental Member Voting Representatives are registered and validated to be eligible to vote on code changes. All Primary Member Representatives need to designate or revalidate their Governmental Member Voting Representatives (GMVR) online by **August 31, 2015** to be eligible to vote at the Annual Business Meeting or Public Comment Hearings.
