### **Online code change submittal deadline date moved to January 10<sup>th</sup>**

To give you more time to become familiar with cdpACCESS, and because of the year-end holidays, the online code change submittal deadline date has been moved to January 10 from January 6. The hearings offer Code Council Members and others in the construction industry an opportunity to voice opinions and offer expertise to help develop the 2015 *International Green Construction Code*. cdpACCESS — the new, online component of the code development process — will be used for the first time at a hearing allowing greater participation from code change submittals to discussions and final voting. ### **New HUD Regulations for Public and Indian Housing Reference IECC**

The new rulemaking for the Department of Housing and Urban Development's Public Housing Capital Fund Program now incorporates energy efficiency standards, incorporating by reference the 2009 International Energy Conservation Code (IECC). This comes as a result of comments submitted by the Government Relations staff on the original notice of proposed rulemaking, and marks a significant commitment to energy-efficient and code-complaint housing for our nation's most disadvantaged citizens.

## **Upcoming Changes to ICC Exam Appeals Process**

On January 1, 2014, the candidate exam appeals process will be significantly changed, to allow Certification and Testing to focus resources on those candidates who have a justifiable concern.

The current policy can be found in the [National Certification Exam Information Bulletin](#). It allows a three-step process at no charge to be initiated within 90 days of failing an exam.

Starting January 1, a mandatory \$100.00 fee will be required when filing a formal challenge of a failed exam and this initial challenge must take place within 30 days of receipt of your exam results. ICC will continue to post updated forms and information about the process changes over the coming weeks.
